

# Remarking Australian Imported Meat Products Using Meat Messaging



#### FSIS Directive 9900.5 For Label Verification of Imported Meat, Poultry, And Egg Products

When an Australian product has been refused entry because of partial, completely illegible or missing shipping marks, the FSIS Directive 9900.5, Section VII, E allows procedures for correcting shipping marks when using barcodes.

FSIS permits official import inspection establishment personnel to apply the shipping mark to shipping units without having an official representative of the foreign inspection system on-site to approve and observe this activity when FSIS IPP can verify the unique identifier within a barcode on the shipping unit using supporting documentation provided by the foreign country.

### How Meat Messaging can improve the re-certifying process

Meat Messaging acts as an alternate protocol for managing illegible or missing shipping marks for the U.S. compliant to FSIS Directive 9900.5.

The USDA FSIS official important inspection establishment can log in to the Meat Messaging website or via the Meat Messaging app on their phone or tablet and search using the case barcode number or the Health Certificate Number.

The USDA FSIS official important inspection establishment can then download the consignment report information, print off the "Al Carton Serial Number Report" showing the Health Certificate Number and individual shipping units barcode numbers and present it to the FSIS representative which can then be **approved within minutes.** 

### The instructions below are for the Meat Messaging website search:

**Step 1:** Log in to Meat Messaging (<a href="https://www.meatmessaging.info/">https://www.meatmessaging.com/</a>) website with your username and password. Or download the Meat Messaging App and log in to the App.

- **Step 2:** On the website main menu click the **Search** button.
- **Step 3:** Enter a Health Certificate number or barcode into the search field related to a carton that has a damaged or missing shipping mark. Then click the **Search** button.
- **Step 4:** Click the blue 'Barcode List' button to display the PDF of the consignment details and the full list of the carton barcodes.
