Why is Adding the Health Certificate to the Consignment Important?

Any messages that don't have a health certification as shown in the column for Health Certificate for export messages on the list of messages can have the health certificate added by the Non-Packer Exporter by entering it manually or programmatically through their internal systems.

Health certificates need to be added to a message so that at the time of import inspection, the message can be found through a search using the health certificate. For example; if a carton has a missing shipping mark and has a rejection notice attached to the product, the import inspection facility can remark the product by searching the health certificate number for the consignment.

What is an Advanced Shipping Notice and Why is it Important?

An Advanced Shipping Notice (ASN) sends all of the relevant consignment information of a load to the consignee. When the health certificate number is added to the export information, the advance shipping notice sends all of the barcode information, and relevant product information to your consignee to keep them updated and informed.
