How to show an export Establishments U.S. Import Refusals / Rejection Ranking

The USDA FSIS publicly publish a detail list of the import refusal/ rejections every few months through the FSIS website dataset program. This FSIS data is automatically imported in to Meat Messaging and used to generate the "Meat Messaging Red Meat Rejection Ranking from Australia to the U.S." report. This report ranks export establishments from worst to least rejections. The report is de-identified for all establishments except for the establishment for the user that has logged in and is see the report. This process allows the user to see where their establishment sits on the Australian rejection ranking.

The Rejection Benchmarking report shows a chart of the Establishment against 75% benchmark and the Rejection Listing show the details of each rejection.

Step 3 A – US Ranking Details:

The Rejection Ranking report will then be displayed. If the logged in Established has had rejections in the last 12 months they will be highlighted in Red on the report showing their rank, rejection count and refused weight.

Below is a table outlining the de-identified export establishments in Australia ranking from worst to best based on the total number of rejections from the U.S. they received within the date range. Products are rejected due to Invalid Shipping Marks, Shipping Damage or Invalid Inspection Certificates. Rejected meat is either destroyed or turned into processed pet food which equates to a huge loss for the organisation. FSIS Data may be delayed up to a few months.
